

WARNING TO ALL EXHIBITORS

Dear Exhibitors,

It has come to the attention of Guangzhou Guangya Messe Frankfurt Co Ltd (an affiliated company of Messe Frankfurt (H.K.) Limited), the Organiser of the "GUANGZHOU INTERNATIONAL LIGHTING EXHIBITION", that some companies claim to be publishers of exhibition or trade directories have sent letters to exhibitors inviting them to update or correct their data with their directories and, at the same, enclosing a Form for placing advertising space with them at a fee. Attached please find, for your attention, a letter to one of our exhibitors from one such company alleged to provide free listing service for a publication called "International Fairs Directory" enclosing a Form bearing our trade fair name "GUANGZHOU INTERNATIONAL LIGHTING EXHIBITION" in the heading.

The Organiser **HEREBY DECLARES** that it has no connection whatsoever with the listing and publication of "International Fairs Directory" and it has not authorised such company to act in any capacity to approach or deal with its exhibitors in any way on its behalf for any of its trade fairs nor has the Organiser authorised such company to use its company name, any of its trade fair names, trademarks or logos.

Should exhibitors receive letters of similar contents in relation to International Fairs Directory or from any other similar companies requesting exhibitors to complete any form, please be vigilant and **DO NOT SIGN AND RETURN** any form in order to avoid financial loss and commitment. In the case of International Fairs Directory, the form contains small prints, once signed, it will bind an exhibitor for a minimum term of 3 years with annual payment of 1212 EUROS for the "advertising fee" unless terminated earlier or cancelled in the manner as prescribed.

For your information, UFI, an international organisation which represents the interests of the exhibition industry worldwide has been warning the exhibition industry to be vigilant against similar companies. UFI has also reported that debt collection agencies work in partnership with these companies to intimidate exhibitors for payment (for more information, please visit <http://www.ufi.org/industry-resources/warning-construct-data/>)
